¹ *Some of these vehicles may have more than one Takata recall campaign PRA number associated with them. If yes, then only the most recent Takata recall campaign PRA number applies to that Toyota vehicle. For example:*

- If the Alpha airbag has not been replaced under PRA 2014/14456, then PRA 2017/1604 applies. This is because Toyota Australia received parts in 2017 to replace these airbags with a desiccated Takata or alternate airbag (i.e. not with a 'like for like' airbag). If the Alpha airbag was replaced under PRA 2014/14456, then the vehicle will now be subject to active recall for replacement of the 'like for like' airbag.*
- Vehicles in campaigns PRA2018/17146 and PRA 2019/17788 were previously repaired by replacing the affected Takata airbags with new Takata non-desiccated airbags ('like for like' airbags) under another PRA number. This was to secure immediate safety in the face of parts supply challenges globally. To ensure long-term safety, the replacement airbags are now being replaced again under PRA 2018/17146 or PRA 2019/17788.*

² *Some Corolla ZZE122 vehicles in recall campaign PRA 2015/14701 and PRA 2018/17146 are also affected by a separate but interacting safety recall campaign relating to a defect in the electrical wiring for the airbag.
